**DIRECTIONS FOR USE**

**General:** Apply in solution at the rate of 1 pound in 5 to 20 gallons of water. Apply in early morning or late afternoon, avoiding periods of heavy direct sunlight. For best results, premix the required amount in water prior to adding to the spray tank or concentrate tank.

**Sprayers:** Use a sprayer with a boom, floodjet, handgun, or similar applicator. Calibrate sprayer to determine the area covered per tank.

Determine amount of Bermudagrass Special 20-5-30 required at the rate of N per 1,000 square feet you wish to apply using the following chart:

Multiply total sprayer coverage by weight required. This determines the amount required per tank load.
